A Considerations on CD11 Proposed Development Projects (Jim Murez on behalf of the Parking & Transportation Committee, james.murez@venicenc.org)

**MOTION:** WHEREAS, the VNC understands the city is proposing two large development projects within the Venice region and the coastal zone; and

WHEREAS, these development projects are located within primarily residential neighborhoods; and

WHEREAS, the public right of way is substandard to meet the current demands much less additional demands; and

WHEREAS, these proposed sites are in or accessed by high traffic/high density areas; and WHEREAS, the city has previously determined the intersections at and around these sites are already in excess of "F" intersections; and

WHEREAS, any development project should mitigate the existing conditions before adding any additional impacts or increase in traffic; and

WHEREAS, the VNC Parking and Transportation Committee recommends that all large development projects should mitigate their traffic impacts; and

WHEREAS, one of the proposed projects will increase the traffic at Venice Blvd and Pacific, which is already an extremely overtaxed intersection which backs up in all directions; and WHEREAS, LAPD is already required to dispatch traffic officers to that intersection during many peak periods of the year; and

WHEREAS the proposed development in the Oxford Triangle in what was previously known as the Thatcher Maintenance Yard shall cause significant impacts to the single-family residential neighborhood within the Oxford Triangle;

THEREFORE be it resolved that the VNC requests that the City present a mitigation plan capable of improving the present heavily impacted areas and providing for zero additional negative impact on public right of ways, including sidewalks, roads and public landscaping, from the proposed developments.

- C Oxford Triangle Resolution (George Francisco on behalf of the Neighborhood Committee vp@venicenc.org)

**MOTION:** Whereas, the City-owned Thatcher Yard operated in the heart of the Oxford Triangle for decades; and

Whereas, even at full capacity, the Yard was only open about 50 hours per week and was closed every night, weekend, and holiday; and

Whereas, city operations on the Yard generated a minimal amount of noise and traffic; and Whereas, any new residential development on the site will generate far more traffic throughout the day and night and weekends through the Oxford Triangle neighborhood than City operations did; and

Whereas, in 1988 Oxford Triangle residents participated in the Oxford Triangle Neighborhood Study as part of the Venice Neighborhood Study Presentation Workshop, which was sponsored by the District Council Office and City Planning Department and contributed to Development Standards and the Local Coastal Program for Venice; and

Whereas, the Oxford Triangle Neighborhood Study was completed and presented on November 5, 1988, and states under Zoning preferences (Section 1, Page 10, Item 16) that: 'The City Maintenance Yard and other City owned lots in the residential area of the Oxford Triangle must remain R-1' (be zoned for single-family homes) if the City decided to abandon operations at the site; and

Whereas, the industrial property at the southeast end of the Oxford Triangle was rezoned C4-OX-2D in the 1980s to allow high-density residential development, and almost 1800 units of condominiums and apartments in six dense developments have been built on that property since that time, which increased the density of the Oxford Triangle five-fold; and Whereas, in 2010 the City of Los Angeles held a series of public meetings to advise the community of its plans to demolish the existing structures at Thatcher Yard and replace them with new buildings and take public input, and at that time City representatives stated that the City intended to complete this project in the near future to allow the City to resume maintenance operations from the site; and

Whereas, it would be prohibitively expensive for the City to acquire additional Westside property of a similar size or to rezone such property for use by City departments for maintenance operations in Venice and adjoining City districts such as Mar Vista and Del Rey due to community opposition; and

Whereas, the Los Angeles City Request for Qualifications/Proposals identifies Thatcher Yard as an Affordable Housing Opportunity Site which would allow development of Permanent Supportive Housing for homeless individuals, Affordable Multi-family Housing or Mixed-Income Housing at the Yard or sale of the property with the proceeds used to fund homeless housing at another location; and

Whereas, all buildings on and walls around Thatcher Yard have now been demolished; and Whereas, there have been no public hearings in Venice or by the Venice Neighborhood Council on the proposal to redevelop Thatcher Yard as permanent supportive housing or affordable multi-family housing or to sell it to generate funds to build such housing at other, more affordable and appropriate sites; and

Whereas, the City has selected Thomas Safran & Associates to develop a dense apartment complex on this site in contradiction to the 1988 Neighborhood Study's commitment to single-family residential zoning; and

Whereas, the Oxford Triangle's existing low rise, single-family homes offer a unique Venice beach residential neighborhood that is a prized for its lack of traffic and noise, and residents purchased homes in the Triangle in part for these qualities and ambiance;

Therefore, be it resolved, that the Venice Neighborhood Council recommend to Mayor Eric Garcetti and Councilman Mike Bonin to honor the request of Oxford Triangle residents and the recommendations of the 1988 Oxford Triangle Neighborhood Study to either rebuild maintenance facilities on the property known as Thatcher Yard to resume City maintenance operations or rezone the property to R1-1 status to complement and protect the Scale and Character of the adjoining single-family residential neighborhood and then sell the property to a developer who intends to redevelop the site in a manner consistent with existing Oxford Triangle single-family homes.

Absence from four (4) consecutive meetings or seven (7) or more meetings during the previous twelve (12) months shall be deemed a failure to consistently attend. A three-quarters (3/4) vote of Officers present at a Board of Officers meeting is required for removal. Such action shall be effective immediately upon the Board vote to remove. In such case, the President shall send a certified letter to the person, stating that he or she is no longer an Officer."

**MOTION:** The Venice Neighborhood Council recommends removal of Erin Darling from the Board due to 5 consecutive absences from the last 5 board meetings. (Oct. 2016-Jan. 2017) NOTE: there were 2 Board meetings in October, 2016.)

If approved by Board, nominations for selection of replacement Board member shall be opened.

**Community Impact Statement [CIS] in support of Council File # 15-1022-S2 Suspension of online voting** (Ivan Spiegel on behalf of the Los Angeles Neighborhood Council Coalition "LANCC")

**MOTION:** Whereas the City plans to change Neighborhood Council election procedures unilaterally and.

Whereas the City plans to make all NC elections self-affirmation against the will of some boards and bylaws, and

Whereas the City plans to reduce unilaterally the voting age of stakeholders in some NC's to 16 years of age against the bylaws and will of the boards, and

Whereas the City is mandating all NC's use online voting only, against the will of the some boards who voted against online voting, and

Whereas the City is attempting to mold neighborhood councils to fit an electronic voting model rather that fitting the contracted for electronic voting model to neighborhood councils,

Therefore be it resolved that the Venice Neighborhood Council shall file a Community Impact Statement in support of Council File 15-1022-S2 and demand the City suspend online voting unless and until it can show evidence that the online model is complete and secure as contracted for, that the City will provide proper outreach, that the Department can show it has returned to its core mission of supporting NC's, and can truly support neighborhood councils per its Charter mandate, and allow all of the councils, per the Charter, Ordinance and Plan, to self-rule for the benefit of its stakeholders, and to allow the NC's to determine whether it should be online, self-determination and age specific for its voters.

H CIS in support of Council File # 17-0078 "Back To Basic Car" proposal (Councilmember Mike Bonin)

WHEREAS, basic patrol duties are universally considered to be the core function of law enforcement, and cities like Los Angeles with large police departments are no exception; and WHEREAS, despite strong public support for maintaining a police force of 10,000 efficers, neighborhoods throughout the City of Los Angeles continue to lack the most basic police patrol presence and experience response times that are exceedingly long, while crime continues to increase; and

WHEREAS, an abundance of evidence suggests that the strength of LAPD's field patrol force has not increased in almost a half century, despite the addition of thousands of sworn officers to the ranks of the police department and the addition of three new community police station areas

WHEREAS, the historic pattern of understaffing our neighborhood police patrols by LAPD's top brass—especially in light of the significant increases to the overall size of the force—suggests that field patrol duties are neither a priority, nor viewed as a core mission within the police department; and

WHEREAS, the lack of consistent police patrols endangers our community by increasing response times and sends a dangerous message to the criminal element that our homes and businesses lack adequate protection; and

WHEREAS, neighboring cities with significantly smaller police departments have demonstrated that it is possible to provide comprehensive law enforcement services, while also providing robust neighborhood patrols, maintaining fast response times, and building strong police-community relationships using regularly assigned patrol officers; and

WHEREAS, all Angelenos, especially the Venice Neighborhood Council, have the expectation that our police department makes every effort to ensure the most efficient and effective use of sworn personnel, which means deploying as many able-bodied police officers back to patrol car beats as possible; and

WHEREAS, residents, rank and file police officers, HOAs, neighborhood councils, business owners, community leaders, neighborhood watches, local schools, religious institutions, labor groups – including the LA Police Protective League, business associations, business improvement districts and chambers of commerce from throughout Los Angeles have united around a single cause: more police patrols;

NOW, THEREFORE, BE IT RESOLVED that the Venice Neighborhood Council shall file a Community Impact Statement in support of the "Back to Basic Car" proposal (Council File # 17-0078) authored by Councilmember Mike Bonin and co-sponsored by Councilmember Joe Buscaino — a smart, sensible and achievable neighborhood police patrol enhancement strategy that would result in a larger and more robust LAPD patrol force, and would greatly improve the safety of neighborhoods throughout Los Angeles.
