1. CALL TO ORDER/ROLL CALL:

2. APPROVAL OF 4/6/2006 MINUTES:

3. APPROVAL OF THE AGENDA:

It was noted that the Land Use & Planning Committee modified and resubmitted the agenda request originally submitted at the 4/6/2006 meeting; however, it was received past the deadline to notice on the agenda. 4. PUBLIC COMMENTS:

**Suzanne Thompson** presented a request from the Venice Arts Council for \$5000 preliminary seed funds for their "Endangered Art Fund." The request was referred to the GRVNC Arts Committee for consideration.

**Suzanne Thompson** presented a request from Inside Out Community Arts for \$5000 to help defray the cost of their annual production of the Youth & Family Court at the Abbot Kinney Street Festival. The request was referred to the GRVNC Events Committee for consideration.

**Phil Rader** requested that GRVNC set up an account for copying with a local print shop. CJ will explore how to make it work within DONE funding guidelines. Suzanne will contact Lincoln Stationers; Phil will contact Staples.

5. REQUEST FROM LAND USE & PLANNING COMMITTEE:

Request for: 1) \$170 to purchase LA City Planing & Zoning Codes with updates through the end of the year; 2) \$277 to purchase 2002 LA City/California Building Code (complete set) for use at LUPC meetings. Committee took no action. It was felt that there were sufficient funds already allocated.

6. REQUEST FROM OVERNIGHT PARKING DISTRICT COMMITTEE:

Agenda item moved to Preparation of Draft Budget for Fiscal year 2006-2007.

Forms must be returned to CJ prior to the next meeting.
