6) Under what kinds of situations do you feel it to be appropriate to grant exceptions or variances to the Venice Specific Plan or other LA City Planning codes?

If a proposed development aligns itself with transit and incorporates affordable units, then depending on the location and design, it might make sense to grant permission for a couple of extra floors above the height limit.
