



Ms. Pollack Erickson with assistance before hand from Mr. Chris Williams, advocate for neighbors opposed to St. Joseph Center at Lincoln and Flower, will go to the VNC Board to get approval to send out a letter to neighborhood schools of the impact on the safety of the children in the Venice-Mar Vista Community, as a result of St. Joseph's Drop-In Center. This motion passed 2-0.

Mr. Kosolow will have a report on his LAUSD investigation of the Walgrove Park and Jogging Area on March 15, 2007 and why community, parents, and children are denied access to this park and jogging track built with Prop K funds. These funds are public, and Ven Mar and/ or Friends of Walgrove informed community this track and park, which sits idle after school, on weekends and during school breaks was to be open three years ago. This track has also been requested by the physically challenged and elderly in the area as a safe walking track.

Ms. Pollack Erickson brought Ms. Tanya Anton to make a presentation. Ms. Anton, an educational activist mommy in the MVCC Mar Vista Beethoven area, assists young parents with how to survive in LAUSD with a book she has written. Ms. Anton was quite charming and a very sharp business person. Ms. Anton is interested in a parent forum to help out young parents to bring back local parents to local schools.

This advocate suggested that this be a Venice-Mar Vista NC combined project where all PTAs, booster clubs, etc. send parents to a forum designed by former Parent Collaborative Chairperson Bill Ring who is one of a few who has the trust of both the community and LAUSD. If Mr. Ring would consider this undertaking, either a late May or late September forum would be practical. Rather than rush, the quality of the product and proper organization is more important than a few months.

As there has never been a MVCC-VNC collaborative event, what might be more appropriate than a educational forum to bring back community kids to community schools with a focus also on safe passage. This might be a good next step after the outstanding forum of spring 2006' put on by MVCC Education under current MVCC Chairperson Rob Kadota and Amy Lawrence, former Education Chair with the help of School Board President Marlene Canter and District 3 Superintendent Grace Strauther.
