This letter is to advise that at a regularly held public meeting of the Venice Neighborhood Council's Board of Officers on Tuesday, August 21, 2012 it was moved and unanimously passed by the Venice Neighborhood Council as follows:

To support approval of the project as presented noting:

- All conditions imposed by WLPC and ZA for neighboring Cafe Gratitude, except quarterly meetings.
- No relief from parking required from original entitlement of the building,
- 2750 sq ft total SFA
- 78 indoor and 58 patio seating
- Hours Of Operation: 8a-Midnight daily
- Type 47 full alcohol license
- Patio to close at 10p Sunday-Thursday, 11pm Friday and Saturday
- At least 20 bicycle racks on-site
- Permanent (iron) barriers 3ft high surrounding patio
- 31 parking spaces on-site and 90 minute validated parking with all sales; no relief from parking per VCZSP
- Plan approval after 5 years or change of ownership and / or operator (Vittorio Viotti and Roberto Ivan)
