This will advise that at a regularly held public meeting of the Venice Neighborhood Council's (VNC) Board of Officers on March 20, it was moved and passed by the Venice Neighborhood Council as follows:

To approve the project noting the following conditions:

Recommend approval of the side yard setback variance request noting:

- Side Yard Setback of Single Family Dwelling: Continued maintenance of north side yard setback of 3'-8" and south side yard setback of 4'-0". A 4'-0 north side yard setback for new detached garage and a 4'-0 side yard setback for new recreation room at second level above as required.
- And as condition of approval, the <u>front fence and hedge height</u> bought down to 42" while the gate and pilasters may remain over height as existing.

Please see attached Land Use and Planning Committee (LUPC) Staff Report revised to reflect amendments by VNC to original LUPC motion passed 2/15/12. At the ZA hearing, held March 1. 2012, Associate Zoning Administrator Maya Zaitzevsky agreed to hold open the decision on this case until March 30, 2012 so that the VNC could vote on the LUPC motion and send this letter to her to advise of the results.
