

## Venice Neighborhood Council Elections Are Coming April 11, 2010!

Now is your opportunity to have a say in Venice! The terms of all twenty-one **Venice Neighborhood Council** members are expiring and every position is up for grabs. Forty-three of your friends and local Venetians are vying for positions as VNC Board Members, the largest group of candidates ever to run for the Council.

On Sunday, April 11, 2010, from 10am-4pm, the VNC will hold its biennial elections at the Oakwood Recreation Center. And, for the first time in Neighborhood Council history, the Los Angeles City Clerk's office, as opposed to the VNC itself, will be conducting the election.

Whether you live, work, own property, or have a verifiable interest in Venice, you are a VNC "stakeholder" and eligible to vote on April 11th; no pre-registration is necessary.

The election could not come at a better time for our community. The City faces a massive budget crisis that is sure to affect us here in Venice. City services will be curtailed (including those provided by the VNC) just as we are dealing with critical quality-of-life issues:

- Improving the evolving commercial and residential character of Venice
- Homelessness issues
- Stopping the recent increase in crime
- Addressing increasing amounts of traffic and dealing with the challenges of parking and congestion
- Regulating Ocean Front Walk and working to preserve it as one of Southern California's greatest tourist attractions

Over the past several years, through the hard work and dedication of the VNC and its stakeholders, the VNC has become an important part of Los Angeles City government. The VNC's recommendations are closely watched, and more often than not, are followed by our City Councilman, the City Council and the Mayor.

However, the VNC's, and thus our local community's voice, is only as strong as our election turnout and stakeholder participation. Community involvement in the VNC has grown to an all time high, with hundreds of people routinely attending Town Hall meetings and 1,600 Venetians voting in our last

referendum election in February of 2009. Notwithstanding this growing participation in our community, it is imperative that all Venetians vote on April 11th. Voting sends a strong message to the City that Venice is as engaged and involved as ever, and that we demand our voices be heard by City Hall.

**Note: Parking at Oakwood Rec Center is limited - please consider walking or biking to the polls! And remember that turnout could be high and lines may form - so plan accordingly! 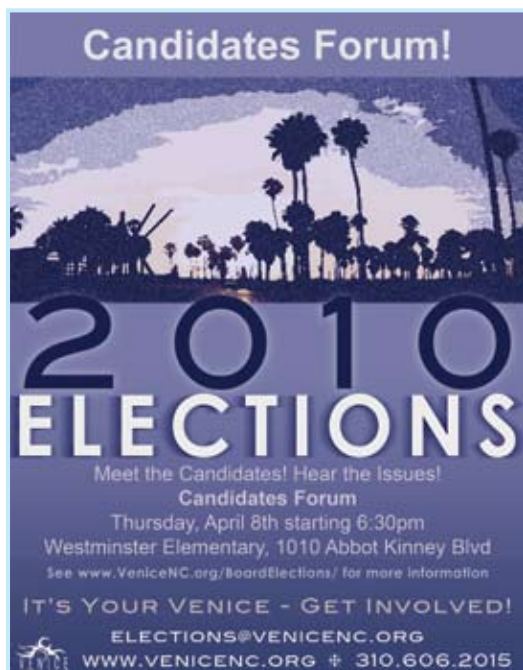
#### Good News from the VNC Neighborhood Committee:

It's with mixed emotions I write this final message to my neighbors as President of the **Venice Neighborhood Council**. After three and a half years on the VNC, and two and a half years as its President, I feel tremendously proud of what we have done and grateful for the opportunity to have served. But I also feel that we have only scratched the surface of what needs to be done.

## A Letter From The President...

Over the past two and a half years, all twenty-one of your VNC Board members have served with distinction, and made great strides towards making Venice a better place. The Council has made it a priority to engage and involve every neighborhood in Venice; whether through our Neighborhoods Committee organizing for disaster preparedness, or the Land Use and Planning Committee working with communities where a project is proposed for siting. Community Outreach has risen to a new high, with the VNC's work being more effectively communicated to us all through our newsletter, *Your Venice*, increased press coverage, e-mail alerts, and community tabling at the Venice Farmer's Market and First Fridays. We have also

taken the concept of Town Hall meetings to a new level, creating interactive forums where hundreds of Venetians come together to discuss an issue, make concrete recommendations, and forward their input directly to the City Council and Mayor.

More specifically, the VNC has worked with the merchants of Abbot Kinney and the Venice Chamber of Commerce to create First Fridays. We have helped make recycling on the Boardwalk a reality, added trash cans and recycling bins throughout our commercial districts, and created the Bin Your Butts program, which seeks to keep waste out of our ocean by providing receptacles for cigarette butt disposal.

The VNC has also taken an active role in the Neighborhood Council

system and in the City. We've been a big part of creating the Westside Regional Alliance of Councils, which brings all 13 Westside Councils together to cooperate on issues of regional importance. And, through our participation in the Board of Neighborhood Council Commissioners (BONC), Los Angeles Neighborhood Council Coalition (LANCC) and other groups, we've taken the lead on many city-wide issues and contributed to the best practices of the Neighborhood Council System.

We reserve almost 50% of our annual budget for projects proposed by stakeholders and community groups that directly benefit Venice. Our innovative method of basing most of this funding on a

competitive application process has been widely praised and is being emulated all over the city. As for our serious issues regarding homelessness, the VNC has spent the better part of the last two years working with Councilman Rosendahl's office to develop a system for overnight parking permits - for neighborhoods that want them - coupled with a Safe RV Parking program to provide refuge and opportunity for members of our community living in their vehicles.

However, this is just a start, and so much more needs to be done. Over the last year Venice has experienced a small but disturbing rise in property and violent crimes which must be addressed. Our parking and vehicular congestion problems are

growing. The city-wide budget crisis makes it likely the VNC's budget for coming years will be heavily cut at the same time the city's ability to provide basic services to our community is in jeopardy.

Because of all the work that still must be done, I challenge every one of you to get more involved in Venice. Whether that means working directly with the VNC and its committees, starting a neighborhood watch on your street, opening a new business, or simply voting on April 11th doesn't particularly matter. What matters is your participation in making our Community a better place. Remember, It's *Your Venice, Get Involved!*



## The VNC's Land Use and Planning Commission Chair Position is Up For Grabs in This Year's April 11, 2010 Election:

*Current Chair Urges Her Successor to Ensure Developer Compliance With Conditions Imposed on Projects*

*Editor's Note: Challis McPherson, after years of serving as the Chair of the VNC Land Use and Planning Committee ("LUPC"), is not running for re-election. Two candidates are vying for her position. When asked what advice she might offer*

*her successor, McPherson wrote the following:*

It is important to ensure that developers adhere to the conditions placed on projects. If I could do anything differently, I would place more emphasis on following up on conditions

that the City imposes on development projects.

Some developers, not all, attempt to "game" the system by accepting a community's conditions to obtain project approval and then ignoring both the community and the conditions as the project progresses.

This is wrong. In all likelihood, a community would not accept a project without such conditions, LUPC and the VNC would not recommend approval of a project but for such conditions, and/or the City would not approve projects absent such conditions. That some developers choose to ignore these conditions, and that the City does not do a better job enforcing compliance is simply

unfair to our community.

To ensure better compliance with conditions, in 2006, LUPC recommended the following draft amendment to State of California Code, Section 27281.5:

*(d) A Municipal Government entity may, by ordinance approving or granting a discretionary land use right also provide for the right to record the conditions of approval on behalf of the developer, at the discretion of the Municipal Government entity, at any time after the expiration of six months following the date of its approval of the conditions and the granting of a vested development right.*

Such language would ensure that agreed-upon conditions are legally placed on a project and that violations of those conditions are

actionable. Apparently, the draft amendment did not go anywhere. It is my hope that LUPC and its new Chair will continue to explore their options at the local, city and state level, perhaps recommending a similar amendment.

In 2009, Controller Laura Chick's audit of the City of Los Angeles' Planning Department addressed the question: "Who ensures that the requirements attached to these developments are followed?" The answer, she found, is: "No one." We, the community and the City, rely on voluntary compliance by the developers.

This simply doesn't work. Voluntary compliance is spotty at best. We are entitled to more.

But until some enforcement mechanism is put in place, the community has to do the follow-up. Using new tracking tools, our ever-increasing knowledge of the City's planning process, and feedback from residents, we can ensure that developers comply with conditions imposed on their projects.

That is why your vote in the upcoming election is critical. Whom you elect to chair LUPC and the VNC Board will shape the next Land Use and Planning Committee. If you are concerned with developers complying with conditions imposed on projects, if you are concerned with adherence to the Venice Coastal Zone Specific Plan and our community's future, please vote on April 11, 2010.

## Venice Neighborhood Council Budget

Until the current fiscal year, the budget parameters for the **Venice Neighborhood Council** were consistent. Each year, the City would appropriate \$50,000 for each of the neighborhood councils. In addition, any unspent funds from the previous three years could be "rolled-over" and were available for expenditures. The VNC planned its annual budget based upon these principles.

Due to last year's serious cash shortage, the City cut the budget for all Neighborhood Councils by 10%. So our annual allocation was reduced to \$45,000. The right to utilize the unspent funds from previous years was retained.

The availability of

roll-over funding was of critical importance to the VNC as our largest category of expenditures has consistently been community improvement projects. These projects are scheduled to be completed during the budget year after the funds are awarded to allow sufficient time for application and approval process, and for the community groups to complete their work.

The City's financial problems reached crisis levels this year, and it looked for ways to stem the outflow of money in places that had been off-limits in the past. As a result, the City decided in February to eliminate the use of any roll-over funds by neighbor-

hood councils. Moreover, the Department of Neighborhood Empowerment [DONE] unilaterally determined that all payments made after June 30, 2009, were to be deducted from this year's funding rather than to be allocated to the budget year from which the funding was originated. This affected projects funded two years ago and completed in the previous year for which payment had been delayed. As a result, the VNC was notified that it had very limited funding remaining.

The City subsequently created a mechanism for DONE to reallocate funding for previously approved projects to the appropriate budget. However, no

decision has been made on the VNC application, which contends that the majority of expenses charged to this year's budget properly should be allocated to the previous two years' budgets. Until this dispute is resolved, the VNC is stymied in its ability to proceed with its remaining projects. Just to complicate matters further, the mayor instituted a spending freeze in March.

At the same time all of this has been happening, the budget process for next year moves on. Although the Mayor has yet to release his budget, the Education and Neighborhood Committee of the City Council initially recommended that the annual

funding for the neighborhood councils be cut in half to \$22,500. The majority of neighborhood councils and the Board of Neighborhood Commissioners have recommended a smaller reduction, to \$40,000. The VNC will be developing two alternative budgets

for next year based on these extremely different funding levels. Whatever funding is ultimately determined, the VNC will continue its commitment to minimize spending on overhead, and maximize the use of funds directly in the Venice community.

## How to Prepare For An Emergency – Home Safety Tips

From the Emergency Preparedness Task Force of Venice Neighborhood Council



The Fire Department says we might have to survive on our own for up to 10 days if a big earthquake hits Southern California. Minimize hazards now and keep yourself and your family safe. This information is gathered from many of the best sources for preparedness. Check out the websites included below for more details.

### What you can do now:

- **Locate, label and review shutoffs for gas, water and electrical utilities. install an automatic gas shut-off valve.**

The City of Los Angeles requires natural gas seismic shut-off valves on gas lines.

The valve automatically shuts off your gas when an earthquake of sufficient magnitude occurs. An excess flow valve automatically shuts off your gas when a significant gas leak or overpressure surge occurs at a pipe or appliance located beyond the point where the valve is installed.

- **Identify potential hazards in your home and begin to fix them.**

People have been seriously injured because of unsecured building contents such as toppling bookcases.

Many billions of dollars have been lost due to this type of damage.

Secure anything 1) heavy enough to hurt you if it falls on you, or 2) fragile and/or expensive enough to be a significant loss if it falls. In addition to contents within your living space, secure items in other areas, such as your garage, to reduce damage to vehicles. Secure hazardous materials to avoid spills.

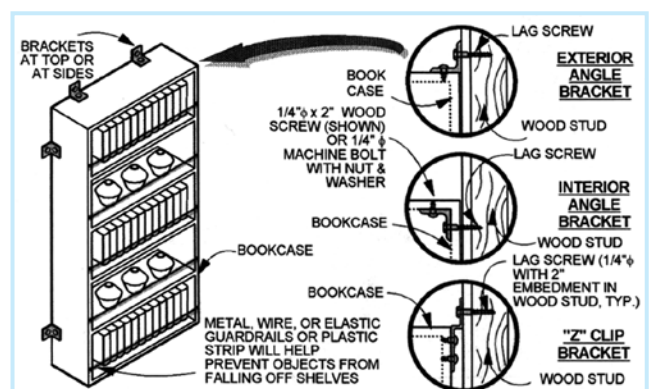
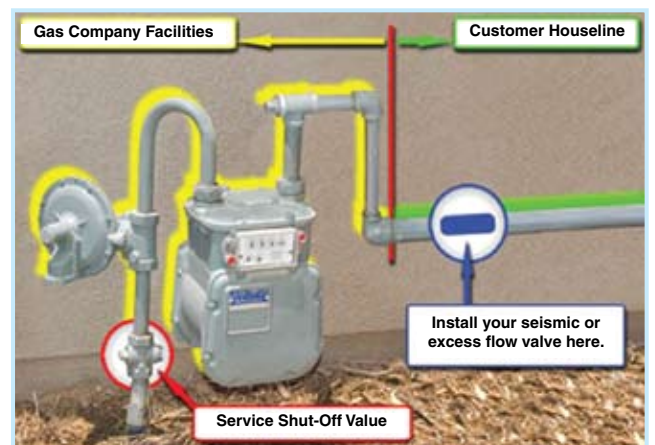

## Democracy: A True Means to Education

Upon coming to the Venice Neighborhood Council (VNC) Education Committee last summer, I encountered heated discussions regarding budget cuts, English learner programs, charters vs. non-charters, and special education learning theories. We were an extremely committed group of people working to strengthen educational opportunities in Venice. Isn't this always the case in education? There we were—together—moving forward to make a difference for our future generations regardless of our personal circumstances.

Any school or organization runs more effectively when it functions in a true, democratic leadership model. We, as commu-

nity members, can facilitate this process by ensuring that we produce positive, solution based ideas any time we are presented with a potential problem. When teachers, schools, and community stakeholders utilize democratic protocols, effective change occurs while hearing all stakeholders' voices.

For example, VNC Education Committee participants meet to discuss educational concerns in Venice. Action items from their meetings are taken to the VNC Board for approval. The VNC Board advises the City... eventually laws and policies are created to reflect the original desires of those VNC Education Committee participants who

made their voices heard. John Dewey, American educational reformer and strong advocate of democracy, viewed schools and civil society as working together to further human intellectual progress. "All those who are affected by social institutions must have a share in producing and managing them" (John Dewey, 1937). I believe this is the perfect quote that encapsulates the importance of educational access and accountability systems. If community members have a sense of power and actual power in the decision making process, there is an individual and collective sense of responsibility moving them towards true educational reform.

The Education Committee's Mission Statement is as follows: "The Committee has the general responsibility for addressing the issues, concerns, programs and services related to the education of children, youth, and adults and developing specific strategies and policies for influencing and achieving constructive outcomes within the schools, classrooms, and other education/learning centers that serve

the Venice Community." The purpose of education is to clear the learning path so individuals can realize their full potential as human beings. Our purpose as teachers, administrators, parents, and community members is to engage our community in critical thinking activities to promote positive changes at home and in the community.

My hope for the upcoming VNC Board and Education Committee is to think beyond kindergarten through college education. We as the Education Committee must continue to look to all Venice Stakeholders as students. Learning does not stop at middle and high school graduations. Educational opportunities should be available to all stakeholders beyond college. Lifelong learning takes place beyond the classroom in VNC Town Halls, cooking classes at the Venice Skills Center, and piano lessons at the Oakwood Recreation Center. We all are the students in our community.

Over the past year as Education Committee Members, we have instituted Spanish translation for our agendas, encour-
