This will advise that at our regularly held public meeting on February 17, 2009 it was moved and passed 17-2-1 that the Venice Neighborhood Council recommends supporting the referenced planning case with the imposition of the following conditions of approval:

VNC Board of Officers accepted LUPC staff report on 712 South Lincoln Blvd. ZA 2008-2911 CUE ZV, and recommendation to approval the project as conditioned.

Applicant is requesting sale and service of beer and wine for on-site consumption in conjunction with the operation of a new full-service restaurant having 48 seats. Proposed hours of operation and alcohol service are from 8am to 12am seven days a week. Variance to allow a reduced parking count with off-site parking on an adjacent lot secured via Covenant. Site presently a vacant liquor store, proposed use as a restaurant. Applicant requesting relief from LAMC 12.21-A,4 (9) (g), and the LAMC section which authorizes relief is 17.27. This is about a variance from LAMC section 12.21-A, 4(9)(g) to allow reduced 8 parking spaces in lieu of the required 10 parking spaces to be provided off-site (next door at a vacant lot) by Covenant.
