At the Board's regular November meeting of every year, the VNC Board shall appoint a <u>Legal Liaison</u> and Alternate Legal Liaison (should the <u>Legal Liaison</u> not be available) to seek legal advice from the City Attorney's Office. The Administrative Committee shall recommend a <u>Legal Liaison</u> and an Alternate Legal Liaison to the Board which may then appoint the individuals recommended by the Administrative Committee or appoint different individuals as it deems appropriate

Requests for legal advice can be submitted only by a Board member in writing to the <u>Legal Liaison</u> (or <u>Alternate Legal Liaison</u>) who shall be responsible for making all such requests and City Attorney responses immediately available to the Board and public, and shall further provide the

Board with a report at all regular board meetings concerning the status of any legal advice requested from or provided by the <u>City Attorney's Office</u>.

This provision shall not apply to individual conflict of interest questions which can be presented by any such individual directly to the City Attorney's Office.
