B. LAUSD to Consider Charter Operator Applicants' Quality for Walgrove Elementary; Cindy Chambers (chambers.cindy@gmail.com)

MOTION: Whereas, LAUSD will soon release an RFP for prospective charter operators to lease land on the Walgrove Elementary School campus; and

Whereas, the Venice community has long sought an additional alternative to only one public middle school serving the area; and

Whereas, there are multiple public elementary school options in the area;

Therefore, be it resolved that the Venice Neighborhood Council recommends that the LAUSD consider first and foremost the applicant's capacity and ability to address the needs of middle schoolers in the RFP evaluation process.

C. Support Ocean Charter School; Birgitte Hellsten (<u>agreatdane@me.com</u>) [EXHIBIT F]

MOTION: Whereas Ocean Charter School was co-founded by several Venice and Mar Vista parents, is currently attended by 51 Venice families and 78 Mar Vista families, and is and has co-located in classrooms on the Venice-adjacent Walgrove Elementary campus in Mar Vista for the last 4.5 years granted them by the Los Angeles Unified School District, and

Whereas the Los Angeles Unified School District has recently issued an Intent to Lease unused space on the Walgrove Elementary campus to a charter school, and

Whereas the selection of a charter school other than Ocean Charter School will result in the eviction of children currently attending school on the campus and potential disruption of children's education in a leading local public school.

Be it resolved that the Venice Neighborhood Council Board shall send a letter to the Los Angeles Unified District Board Of Education containing the following language: While the Venice Neighborhood Council may or may not support any Charter school cooccupying the Walgrove campus, should it be mandated that a school be on that site, we support the continuation of Ocean Charter School's co-occupation. We are concerned about any disruption to the education of Venice children that may result from dislocating students from attending school on the Walgrove Elementary campus.

- 2. Oppose any amendment of the Marina Del Rey LCP that reduces public parking in Marina Del Rey,
- 3. Testify before the California Coastal Commission requesting that it deny the Marina Del Rey LCP Amendment proposed by Los Angeles County
