In Venice, incidents of violence on the heavily-visited Ocean Front Walk are common, and often fueled by alcohol. Presentation by Paul Backstrom, Legislative Deputy for Councilman Rosendahl, Los Angeles Department of Transportation Representative (LADOT):

MOTION: Whereas Main Street from Windward north to the city limit is currently configured with two travel lanes northbound, two travel lanes southbound, separated only by a center line stripe with no turn pockets provided, and automobile parking is provided on both sides of the street as well, and

Whereas the current design is auto-centric and inconsistent with the Venice Neighborhood Council's vision goals, and

Whereas the LA City Department of Transportation has proposed reducing the number of travel lanes on Main Street to one lane in each direction in order to provide for new bicycle lanes in the north and south bound direction. The proposal would also create a center-striped median area that would effectively serve as left-turn pocket for motorists traveling from Main Street to adjacent side streets, hereby reducing the potential for rear-end collisions and ultimately making the street safer for all users. There would be no loss or change to the existing automobile parking.

Therefore the Venice Neighborhood Council supports the LADOT proposal for the Main Street Diet, which will encourage and improve mobility (biking and walking) in the community

E. <u>Proposal for Board Consideration of Negative Dynamic</u>; Joe Murphy (joedmurphy@ca.rr.com)

MOTION: I believe an experienced and competent mediator would see this (see supporting documents) as an opportunity and would suggest the following procedure:

Step 1 Make the unhealthy pattern transparent enough so that it is difficult for those involved to deny it exists. I believe the attached supporting documents achieve this by detailing one familiar example of the unhealthy pattern with which 'key affected parties' are aware. I believe mediators would recognize this as an intervention which attempts to create "cognitive dissonance" and lead to a desire to make a significant change.

Step 2 The VNC Board acknowledges the existence of this unhealthy dynamic and decides to do something about it. This brings the spectrum of interested parties to the negotiating table thru the elected representatives of the Venice Community.

Step 3 The VNC Board: (i) generates a list of problems needing to be addressed by openly discussing what got us stuck and therefore locks us in that mode; and (ii) brainstorms/explores ideas (all ideas welcome) on how to address it. This part requires time to dialogue in a relaxed way – time to ask and answer probing questions in order to understand/appreciate a board member's position and the underlying interests upon which his/her position is based.

Step 4 Experiment with some of these ideas by implementing those that seem most likely to improve things.

Step 5 Consider it a 'pilot experiment' subject to periodic evaluation and modification. This institutionalizes 'learning from experience' as an ongoing element of the process.

Whereas, Ocean Front Walk has become an increasingly busy, year-around tourist attraction; Whereas, the presence of dogs on Ocean Front in crowded conditions poses a safety hazards for people and dogs alike, year-around;

Whereas, people on Ocean Front Walk, including LAPD officers, have been bitten by dogs on Ocean Front Walk;

The VNC moves to support an ordinance extending the ban of dogs on Ocean Front Walk so that dogs will be banned every weekend and holiday throughout the year from 11 am to 6 pm in the wintertime and 11 to 8 pm in the summertime.
