JPods use 1/10th the energy of cars. ET3 uses 1/10th the energy of JPods. These networks can be powered completely withing a solar budget.

The cost savings of solar-powered JPods (<u>www.JPods.com</u>) and ET3 (<u>www.ET3.com</u>) are so significant that we can privately fund the deployment and operation of these networks. We will pay 5% of gross revenues for non-exclusive access to rights of way. When the networks are deployed, we expect we can save your citizens about a car payment per month.

Benefits include: Immediate traffic relief and time savings to citizens, tax producing jobs, increase in tourism, air quality increase, decreased energy use, and much more.

Our only need is for local governments to adopt a free market resolution that allows privately financed construction and operation of transport networks that exceed 120 passenger-miles per gallon.
