The Board will select a new member at the **September 15th** Board zoom meeting. Applicants need to show proof that they are stakeholders either at the Adcom or Board meetings and may be given a short presentation at the Board meeting. No representatives will be permitted to speak for the applicant. Applicants are encouraged to provide background information regarding their technical qualification for this open seat.
